Publications and Conferences

Ann Mari May was an invited speaker in the opening panel discussion, "Leveling the Academic Playing Field," for the 125th anniversary of Bryn Mawr College. The conference featured *New York Times* columnist and Pulitzer Prize winning author, Nicholas Kristof.

Todd Weber's chapter, co-authored with 14 other cross-cultural researchers, "Scientific Mindfulness: A foundation for future themes in international business," was accepted for publication in the 2010 *Advances in International Management: The Past, Present and Future of International Business and Management* (volume 23). An earlier version of this manuscript was designated as one of the best accepted papers for the 2010 Academy of Management meetings and won the Carolyn Dexter Award and all-Academy award for the best paper that focuses on internationalizing the Academy. He also had an article, co-authored with Bill Gentry and Golnaz Sadri, "Empathic Emotion and Leadership Performance: An Empirical Analysis Across 38 Countries," accepted for publication at *Leadership Quarterly*.

Bill Walstad was invited by the San Francisco Federal Reserve Bank to participate in a working group meeting on "Improving Evaluation and Metrics in Youth Financial Education" held October 28-29. He also presented a paper on the "Status of High School Economics" and gave a presentation on the 2012 National Assessment of Educational Progress in economics at the Council for Economic Education annual meeting in Miami, October 8.

Keng Siau's paper, "Important characteristics of software development team members: an empirical investigation using Repertory Grid" was published in the *Information Systems Journal*, 20(6), 2010.

John Anderson will deliver the Pre-Lecture Talk for the E.N. Thompson Forum on World Issues on Wednesday, November 10th at 6:30 pm. The evening's lecture will feature former Senator Chuck Hagel and Chinese Ambassador Zhang discussing the topic, "China Rising: Good News or Bad News for U.S. Workers, Consumers and Investors?"

Emre Unlu has received notice that his paper, "Earned/Contributed Capital, Dividend Policy, and Disclosure Quality: An International Study" with Paul Brockman, has been accepted for publication in the *Journal of Banking and Finance*.

Fiona Nah is ranked #6 in the list of most prolific authors in human-computer interaction research based on journal publications from 1990-2007, according to a book chapter entitled "Human-Computer Interaction" by Zhang, Galletta, Li, & Sun in a forthcoming book, *Management Information Systems*. George Rejda is proud to announce the publication of the 11th edition of *Principles of Risk Management and Insurance* (2010) and the 7th edition of *Social Insurance and Economic Security* (forthcoming July 2011).
